

AGGIE-GATE VIP EXPERIENCE ENTER-TO-WIN FORMS.
Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER

- a. The Aggie Gate VIP Experience contest (the "Contest") will begin on September 17th, 2008 at approximately 6:00 am Pacific Time ("PT") and end on October 2, 2008 at approximately 10:00 am PT.
- b. To participate in the Contest, you may enter via the following method: Beginning on September 17, 2008, visit the meat department at a participating Sacramento area Save Mart Superstore to obtain an official register to win postcard entry form (during regular business hours while supplies last). Complete the postcard entry form including first and last name, complete address, city, state, zip code, telephone number, and date of birth and mail the postcard entry form to: UC Davis Aggie Gate VIP Experience (HKW), 280 Commerce Circle, Sacramento, CA 95815. All entries must be received by **5:00pm** on October 1, 2008 regardless of the date of postmark on the official register to win postcard entry form.

- d. KZZO, KHTK & KYMX are not responsible for lost, stolen, mangled, misdelivered, illegible, incomplete or postage due, or late entries.
- e. Limit one entry per person and one entry per envelope. No mechanically produced entries will be accepted.

2. ELIGIBILITY RESTRICTIONS

- a. The contest is open to all KZZO, KHTK & KYMX listeners who are 18 years of age or older and who reside in the greater Sacramento metropolitan area. Employees of KHTK, KZZO & KYMX (the "Stations"), their licensee, their corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Sacramento metropolitan area and the members of their immediate families and/or households are ineligible to participate or win. Subject to all applicable federal, state and local laws and regulations.
- b. For the purposes of this Contest, KZZO, KHTK and KYMX listeners are eligible to win a contest only once every thirty (30) days and a prize valued at \$600 or more only once every six (6) months. Only one winner per family and/ or household is permitted in any contest.
- c. Winner must present government issued photo identification and sign any required releases in order to claim a prize.

3. PRIZES

- a. Five (5) prizes will be awarded. Each prize consists of two (2) VIP tickets to the UC Davis versus Northern Colorado game on October 4, 2008 and two (2) tickets to the tailgating party prior to the game **which includes food and non alcoholic beverages**. Guest of winner must be 18 years of age or older. Tickets must be redeemed on October 4th, 2008 and are good for the day of the game only. Winner and guest may be required to present a valid ID to be admitted into the tailgating experience. No prize substitutions, cash equivalent, or transfer of prizes permitted except at the sole discretion of the Stations. Prize subject to availability and the Stations reserve the right, at their sole discretion, to award a prize of greater or equal value if the advertised prize is unavailable. All other costs not specifically stated herein, including, but not limited to accommodation, taxes, meals, tips and ground transportation, are the responsibility of the winner. Approximate Retail Value: \$100.00.
- b. All prizes or prize certificates may be picked up at the office of KZZO and KYMX at the address below. The winner will forfeit any prize or prize certificate not claimed by **October 3, 2008 at 5:00pm**. In the event that a

prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Stations are not responsible for the safe arrival of a prize or prize certificate.

- c. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Stations management with respect to the contest are final.
- b. Five (5) winners will be selected at approximately 10:00 am PT on October 2, 2008 in a random drawing from among all eligible entries received by the entry deadline.
- c. Odds of winning depend upon the number of entries received.
- d. Winner will be notified by telephone on October 2, 2008. If winner cannot be contacted within 24 hours of notification attempt, winner forfeits prize and an alternate winner will be selected in a random drawing of all remaining eligible entries.
- e. Winner must execute and return any required Affidavit of Eligibility/Release of Liability Prize Acceptance Form by **October 3, 2008 at 5:00pm** or prize will be forfeited and an alternate winner will NOT be chosen. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, potential winner forfeits prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. Winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by the Stations in a calendar year with an aggregate value of \$600 or more. - f. The Stations are not responsible for typographical or other errors in the printing, the offering or the administration of the contest, or in the announcement of a prize.
